- b. Obtains final reads for Customer Service.
- c. Delivers interoffice mail to/from the BAWTP and BCRC daily to the Administration Building.
- d. Assists Meter Reader/ Technicians as needed.
- e. Lock buildings daily after business hours and will perform light janitorial services.
- f. Flag traffic for crew(s).

High School or Trade School graduate or equivalent on-the-job training and experience highly desirable.

GENERAL EDUCATIONAL DEVELOPMENT:

a. REASONING:

Apply common sense understanding to carry out detailed but involved written and/or oral instructions.

- **b.** *MATHEMATICAL:* Make mathematical calculations involving fractions, decimals and percentages.
- **c.** *LANGUAGE:* Ability to understand oral and written instructions.
